## Units Consumed

Units consumed are derived from your meter reading and is the total amount of electricity used in a period.

## Connected Load

Connected Load depends on total wattage of appliances you will use on the connection. It impacts Fixed Charges for the connection.

## Fixed Charges

Fixed Charges are dependent on type of connection and connected load. It is a monthly fixed amount on electricity bills.

## Electricity Tax

Some states apply tax on sale of electricity. This is usually in percentage and applied on total bill amount just like any other tax. This amount goes to the government and not to the utility.

Tariff structure determines the rate at which units will be charged in Energy Charges. It shows increase in rates with increased consumption.

## Fuel Surcharge

While tariff structure for electricity is fixed for one or two years, cost of generation varies every month. The surcharge captures the change in cost of electricity generation. The surcharge is applied per unit.

## Electricity Duty

Some states charge duty on supply of electricity. It is mostly an additional cost per unit of electricity. In some states it is also a percentage. This amount goes to government and not to the utility.
